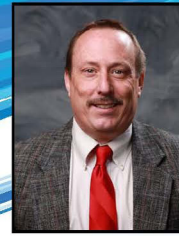

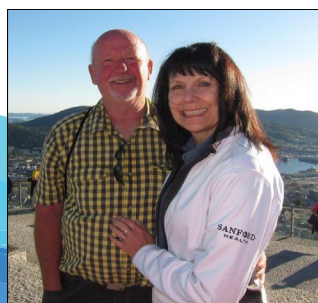
Becky & Dave Nelson Healthcare Career Scholarship

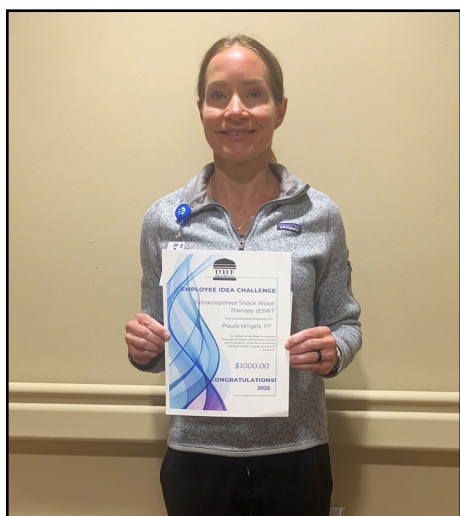
Gayville-Volin Porchlight Project

Dr. Mo, (Melissa Dittberner), PhD, CPS, PS, LMT, is an award-winning lecturer in the Addiction Counseling and Prevention department at the University of South Dakota. She has a Ph.D. in Counseling and Psychology in Education, a master's in Addiction Studies and a bachelor's in health sciences. Dr. Mo is a TEDx speaker, prevention specialist and peer specialist. She is the CEO of Straight Up Care, a telehealth platform for peer specialist. Dr. Mo is the Executive Director of Midwest Street Medicine. She is a co-author of, *The Alcohol Reset*. She does research on college students' substance use, pedagogy, addiction, trauma, body brokering, tattoos as healing and harm reduction. Dr. Mo is a person in long-term recovery and her mission is to empower individuals to learn and navigate their paths to recovery and well-being.



Leadership Dinner 2025 Keynote Speaker:

Andrea Kaman, Lieutenant Colonel, US Army

Lieutenant Colonel (LTC) Andrea Kaman is originally from Wakonda, South Dakota. She commissioned as a Distinguished Military Graduate from the University of Wyoming into the United States Army in 2007 and completed the Adjutant General Basic Officer Leadership Course (BOLC) at Fort Jackson, SC in 2008.

LTC Kaman is currently a faculty member at the United States Military Academy at West Point as part of the Behavioral Sciences and Leadership Department. In that capacity she has taught Military Leadership, Leading Teams, and Leading Changing Organizations. Additionally, she serves as the Director of the West Point Leadership Center and Executive Officer of the Department.

Prior to West Point, Andrea served in numerous leadership and staff positions, most recently as the Human Resources Officer in Charge (S1 OIC) for the 1st Brigade Combat Team, 4th Infantry Division, Fort Carson, CO. Previous assignments include serving as the Congressional Defense Fellow in the office of Congresswoman Marcy Kaptur (OH-9), where she worked primarily on Defense, Veterans Affairs and Homeland Security funding and policy issues followed by an assignment as a Legislative Liaison for the Army in the US House of Representatives. Prior to the Fellowship, MAJ Kaman was Company Commander of Charlie Company, 369th Adjutant General Battalion, Fort Jackson, SC and an AG BOLC Instructor, Soldier Support Institute, Fort Jackson, SC. Her first assignments were with the 12th Combat Aviation Brigade (CAB) in Ansbach, Germany where she served as Deputy Brigade S1 and Task Force XII Strength Manager then Battalion Human Resource Officer (S1) for the 412th Aviation Support Battalion. Major Kaman served a combat tour in support of Operation Iraqi Freedom.

Andrea's civilian education includes a B.S. degree in Marketing from the University of Wyoming (2007), a Master of Professional Studies degree in Legislative Affairs from the George Washington University (2016) and a Master of Business Administration (MBA) degree from the Columbia Business School at Columbia University (2023).

Andrea's military education includes the Command and General Staff College, the Adjutant General Captains Career Course, and the Adjutant General

Officer Basic Course. LTC Kaman's awards and decorations include the Meritorious Service Medal, Army Commendation Medal, the Army Staff Identification Badge, Instructor Badge, and the Parachutist Badge.

Andrea is married to Drew Kaman of Lusk, Wyoming, and they have two children.



2025 Community Health Service Award Recipient

Each year Dakota Hospital Foundation recognizes a community member with the Community Health Service award. This year's Community Health Service award was presented to Matt Lavin. The Community Health Service Award recognizes outstanding contributions of time, talent and resources benefiting the health of the community. We are pleased to present this award every year to someone in the community who we feel encompasses these values.



Matt Lavin

Matt Lavin is the pharmacist and owner of Davis Pharmacy, which has been in business in Vermillion since 1880. He is married to Carol, an RN at Sanford Hospital, and they are the parents of Madisen and Hunter Lavin.

He graduated from Vermillion High school in 1990 and spent the next two years attending the University of South Dakota completing his pre-pharmacy requirements. Although he was accepted into the dental program at the University of Nebraska, Matt chose the pharmacy program at South Dakota State University in Brookings in the fall of 1992. Over the next four years Matt spent about an equal amount of time attending class vs. hunting and fishing. One early spring day while fishing on the big Sioux River with friends, he saw a car slide off the embankment into the water. He yelled to his friends downstream that there was a man in the car. They successfully rescued the 86-year-old driver from the car before it sank into 8-10 feet of freezing water. That justified him missing class that afternoon! Governor Bill Janklow presented Matt with a Certificate of Valor for risking one's own life to save another's.

His relationships with the faculty at SDSU were surprisingly like many of those Matt had while growing up in Vermillion. When introduced to the Dean of the Pharmacy School, on the first day of class, he was greeted with what had become a familiar phrase, "I taught your parents". Matt graduated in the spring of 1996, a member of the last class to receive a bachelor's degree in pharmacy as all subsequent classes at SDSU would receive their PharmD Degrees.

Matt first worked for The Liebe Drug managing a store in Appleton, MN. He remembers that many of

his classmates and friends were heading South for jobs as there were very few opportunities in South Dakota for pharmacists at that time. Matt spent a year working at Booth Drug in Hawarden, IA, before moving to Sioux Falls to manage Lewis Westgate. Happy to be back in South Dakota and working at Lewis Westgate, Matt met his wife Carol, who was a hospice nurse for Sanford. In the fall of 2000, there was an opportunity for Matt and Carol to move to Vermillion. Sanford Vermillion (then Sioux Valley) was looking for a pharmacy director and a hospice director. His wife Carol filled the hospice position. For the next 16 years, Matt was the Director of Pharmacy at the hospital. He also helped at the drug store evenings and weekends. He was named SDSU's College Preceptor of the Year, overseeing over 100 students over the years in their rotations at the hospital and retail. It was a unique time in which Matt worked with both his parents, Sandy (mother) worked at the hospital pharmacy as one of the pharmacists, and Tom (father) was still running the drug store at this time. During these years at Sanford, Matt served seven years on the Vermillion School Board while chasing two very busy children. There were many times where history seemed to be repeating itself with another generation growing up in Vermillion. In 2016 Matt left the hospital and joined his father at Davis Pharmacy, becoming the fourth-generation pharmacist/owner.

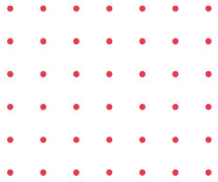

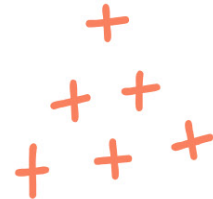
